### WEB APPLICATION TERMS AND CONDITIONS OF USE

## 1. About the Application

- **1.1.** Welcome to Evolution Baseball Australia Online (the '**Application**'). The Application provides online baseball coaching (the '**Services**').
- 1.2. The Application is operated by SRV Baseball Australia Inc. (ABN 19 461 535 081)). Access to and use of the Application, or any of its associated Products or Services, is provided by SRV Baseball Australia Inc.. Please read these terms and conditions (the 'Terms') carefully. By using, browsing and/or reading the Application, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Application, or any of its Services, immediately.
- 1.3. SRV Baseball Australia Inc. reserves the right to review and change any of the Terms by updating this page at its sole discretion. When SRV Baseball Australia Inc. updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

### 2. Acceptance of the Terms

You accept the Terms by using or browsing the Application. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by SRV Baseball Australia Inc. in the user interface.

## 3. Subscription to use the Services

- 3.1. In order to access the Services, you must first purchase a subscription through the Application (the 'Subscription') and pay the applicable fee for the selected Subscription (the 'Subscription Fee').
- 3.2. In purchasing the Subscription, you acknowledge and agree that it is your responsibility to ensure that the Subscription you elect to purchase is suitable for your use.
- **3.3.** Once you have purchased the Subscription, you will then be

- required to register for an account through the Application before you can access the Services (the 'Account').
- **3.4.** As part of the registration process, or as part of your continued use of the Services, you may be required to provide personal information about yourself (such as identification or contact details), including:

- 5.3. You acknowledge and agree that where a request for the payment of the Subscription Fee is returned or denied, for whatever reason, by your financial institution or is unpaid by you for any other reason, then you are liable for any costs, including banking fees and charges, associated with the Subscription Fee

## 11. Competitors

- **13.2.** If you want to terminate the Terms, you may do so by:

  - (b) providing SRV Baseball Australia Inc. with 14 days' notice of your intention to terminate; and
  - (c) closing your accounts for all of the services which you use, where SRV Baseball Australia Inc. has made this option available to you.

- **13.3.** SRV Baseball Australia Inc. may at any time, terminate the Terms with you if:
  - (a) you do not renew the Subscription at the end of the Subscription Period;
  - (b) you have breached any provision of the Terms or intend to breach any provision;
  - (c) SRV Baseball Australia Inc. is required to do so by law;
  - (d) the provision of the Services to you by SRV Baseball
    Australia Inc. is, in the opinion of SRV Baseball
    Australia Inc., no longer commercially viable.
- 13.4. Subject to local applicable laws, SRV Baseball Australia Inc. reserves the right to discontinue or cancel your membership at any time and may suspend or deny, in its sole discretion, your access to all or any portion of the Application or the Services without notice if you breach any provision of the Terms or any applicable law or if your conduct impacts SRV Baseball Australia Inc.'s name or reputation or violates the rights of those of another party.

# 15. Dispute Resolution

# **15.1.** Compulsory:

If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

#### **15.2.** Notice:

A party to the Terms claiming a dispute ('**Dispute**') has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

#### **15.3.** Resolution:

On receipt of that notice ('**Notice**') by that other party, the parties to the Terms ('**Parties**') must:

- (a) Within 14 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;
- (b) If for any reason whatsoever, 14 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon selection of a mediator or request that an appropriate mediator be appointed by the President of the Australian Mediation Association or his or her nominee;
- (c) The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as a precondition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;
- (d) The mediation will be held in 2-6 Pocketwood Place,, Caboolture, Queensland, 4510, Australia.

### 15.4. Confidential

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

#### **15.5.** Termination of Mediation:

If 2 weeks have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

16. Venue and Jurisdiction

The Services offered by SRV Baseball Australia Inc. is intended to be viewed

by residents of Australia. In the event of any dispute arising out of or in relation to the Application, you agree that the exclusive venue for resolving any dispute

shall be in the courts of Queensland, Australia.

17. Governing Law

The Terms are governed by the laws of Queensland, Australia. Any dispute,

controversy, proceeding or claim of whatever nature arising out of or in any way

relating to the Terms and the rights created hereby shall be governed,

interpreted and construed by, under and pursuant to the laws of Queensland,

Australia, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The

Terms shall be binding to the benefit of the parties hereto and their successors

and assigns.

18. Independent Legal Advice

Both parties confirm and declare that the provisions of the Terms are fair and

reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of

inequality or bargaining power or general grounds of restraint of trade.

19. Severance

If any part of these Terms is found to be void or unenforceable by a Court of

competent jurisdiction, that part shall be severed and the rest of the Terms

shall remain in force.
